## Arrival and Departure

- Business Office Hours are 8AM-5PM Monday-Friday
- RV Spaces are reserved from 2PM-10AM
- All sites are first come, first serve. We highly recommend confirming your site with payment
- Payment is due at time of reservation
- Duration of stay is a maximum of 7 days
- Prior arrangements must be made if arriving outside of office hours
- No refunds for early departures
- 7 day notice required for refunds
- Guests are responsible for the actions of their visitors

## Parking and Vehicles

- One (1) vehicle permitted per site plus your one (1) RV
- All vehicles must have current registration, inspection and license plates
- RV should be parked no closer than 6 ft from the building and no closer than 6 ft from other RVs
- Permits are required for all vehicles/RVs that will be parked on the property and must be displayed at all times
- All vehicles must be in operational condition
- No vehicle repairs, maintenance activities, fluid changes, washing/rinsing of vehicles/RV's are permitted on site
- No boats, flatbed trailers, or ATVs
- No parking on grass
- Vehicles are not permitted to protrude from RV site into the flow of traffic
- No type of mechanical repair, whether to vehicle or RV, is allowed
- The speed limit on the property is 5mph
- Parking in vacant RV sites will result in being charged the daily rate of the additional site and/or vehicle being towed at owner's expense
- Visitors or guests must park in the general parking area and are prohibited from parking in other RV sites
- Anyone operating a motorized vehicle on the property must have a valid driver's license

## Rig and/or Site Appearance

- Open flames or non-contained fires for cooking or heating are not permitted (small personal BBQ grills are allowed, but must be contained and enclosed)
- Outdoor items must be neat and orderly
- No ice chests, generators, stacking of boxes, fencing/barriers, pallets, or storage containers allowed on your site
- Keep all cords, cables and hoses coiled and bundled
- Properly size your electric line for your unit
- No light duty extension cords allowed
- Rope, wire, or string may not be attached and strung from vegetation, park property, or poles at any time

## Pet Rules

- All pets must be on a leash (max: 10 ft) in owner's hand at all times while on the property
- Tying pets to fencing, vehicles, etc. is strictly prohibited
- Pets must be cleaned up after while on the property; failure to do so may result in eviction
- Pets are prohibited in restrooms and event facilities
- Pets left alone must be secured in a kennel or dog pen to ensure the pet is not a threat to fellow guests or other pets
- Pets must not dig holes or otherwise create an unsightly appearance or damage to property
- Barking of pets is prohibited
- Visitors with aggressive pets will be banned from the park

## General Rules

- Quiet hours are from 10:00PM to 6:00AM
- All waste must be disposed of in the dumpster located on site at the park
- All wastewater, including gray water, must be disposed of in the Dump Station. Any dumping of waste/sewage on pavement, dirt or vegetation will result in eviction and fines
- Littering on the property will result in fines
- No swimming pools are to be set up on the property
- Rowdiness, loud music, abrasive language, weapons, fighting, lewd conduct, reckless driving/speeding, drunkenness, and possession or use of drugs will not be tolerated at any time
- No fireworks or explosives are permitted within any RV or on the person of any guest
- Selling, advertising, or distribution of any product (including alcohol) is prohibited
- Parents are responsible for the conduct of their children and financially responsible for any damages incurred by their children. Children under the age of 13 must be accompanied by an adult at all times
- DSRP is not responsible for damages
- DSRP will not be responsible for theft or injury occurring during your stay
- DSRP owners or management is in no way liable for any loss or damage by fire, wind, theft, accident or Acts of God
- Registered guests and visitors are liable for all property damages, including risks associated to their person, property, animals, and vehicles
- All federal, state, and local laws must be obeyed at all times
- Emergencies: call 911
