  - This completed application
  - Name of person/group/organization sponsoring production
  - Numbers, names, and ages of all assistants who are to be present
  - Evidence of the applicant's insurance carrier or financial responsibility
  - Number of types of pyrotechnic device and materials to be used
  - Diagram of the grounds/facility where the production is to be held.
    - Shall show point at which the pyrotechnic devices are to be fire
    - Shall show the fallout radius for each pyrotechnic device used in the production
    - Shall show the lines behind the location the audience is mandated to be spectating
  - Point of on-site assembly of pyrotechnic devices and materials
  - Material safety data sheet (MSDS) for the pyrotechnic materials to be used
  - Certificate that the set, scenery, and rigging materials are inherently flame-retardant or have been treated to achieve flame retardancy
  - Must meet or exceed NFPA 1126
  - All plans shall be submitted no later than 14 business days prior to event so the ESD can schedule to be present and have time to notify other interested parties
    - A walk through and a representative demonstration of the pyrotechnics may be required
- Where the use of certain indoor pyrotechnics requires smoke detectors to be bypassed or air-handling systems to be disengaged, the individual responsible for life safety systems of the building shall return system to normal operating conditions as soon as the likelihood of false alarm from the pyrotechnics has been passed.
- Project invoices will be sent via MyPermitNow & posted in the project file on the customer portal – applicant will be notified after submittal has been accepted and processed.
- By signing below, I hereby file this application for a fire code permit and if the permit herein applied for is granted, acknowledge myself to be bound to North Hays County Fire Rescue to see to it that all provisions of the permit are faithfully performed. Authorization is hereby given to North Hays County Fire Rescue and/or their designee, to enter upon the above-described property for the purpose of inspections of proposed construction. I certify under penalty of law that I have personally examined and am familiar with the information submitted in this and all attached documents and believe that the submitted information is true, accurate and complete.
